ACCEPTANCE FOR THE RULES & REGULATIONS OF THE ACADEMY

I/We agree with the following Rules and Regulations of the Academy before taking admission to this course. I am /We are very well aware of the facts of these following rules.

1. The rules and regulation shall be binding on all students. This may be changed without prior intimation to the students. I confirm that the information contained in this application form are true to the best of my knowledge and belief. I have not withheld any material / information that could affect my application/selection. Should any information be found incorrect, I understand that Academy reserves the right to terminate by training without any refund of my fees and the Academy will not be liable to compensate me in anyway. I have read and understood the contents of my Prospectus and agree to all terms and conditions contained therein.

2. I am aware and agree that after selection and joining the Academy, should I withdraw for any reason, no money will be refunded. Also in case, if I discontinue from the course on my own decision after selection (or) dismissed from the Academy by the management. I am liable to pay the full course fee without any balance. Fees once paid are not refundable or transferable for any reason under any circumstances. That no fees, partial or full, will refunded if any candidate is required to leave the Academy during the training period for any reason or either he or his parents wish to withdraw the course of if any candidate found unfit to continue, including medical grounds or whatsoever reason, prior to the completion of the training. After the course commencement, candidates are liable to pay the full fee without any balance whether he completes or discontinues the course. After the admission, If I discontinue the course for whatever reason at any point of time, whatever the fee paid by me will not be refunded even though I did not attend a single class. I agree that when I reserve my seat for admission by paying Reservation Fee and not joining the Course, the fee whatever paid will not be refunded. If I cancel my reserved seat even before the commencement of the course, whatever fee paid will not be refunded.

3. I also agree that the Diploma and Degrees will be awarded by the University as per the nomenclature of the University's decision for the 4-year Marine Engineering course and 3-Year Nautical science and One-year Nautical Science courses. I also agree that Academy has the right to decide the University to enroll my admission wherever applicable for Degree and Diploma Courses & to change the University at any time for conducting the Course.

4. The Academy is approved for specified number of seats for each course. The entire infrastructure and Facility of Academy are utilized by the said seats. Thus each seat involves considerable proportionate cost. Once the course has commenced, new candidates cannot join the course in the midway. Thus each candidate is expected to complete his course in one attempt.

5. If the behaviour of the students is found detrimental to the smooth functioning of the Academy and the hostel, he will be dismissed/ removed from the Academy and the Debarred students will not be Re-admitted. Students are expected to maintain strict discipline in the Academy/Hostel Campus/ Outside during the training period. Use of alcohol, tobacco and other illegal drugs are strictly prohibited. Usage of items such as Cooker and other electrical appliances inside the accommodation room are strictly prohibited. Use of loudspeakers, high volume musical items and any other items which causes disturbances to other students are prohibited. I will not hurt (or) cause discomfort to any of my Teachers (or) fellow students of in doing so I am aware of the disciplinary proceeding against me. Hostels rules are separately given to me and I agree to comply the Hostel Rules & Regulations.

6. The cost of any damage to the property of Academy caused by the students such as damage of Tables, chairs, Cots, Electrical items, Common lifts, Windows, Floors, walls and any other facilities should be paid by the individual trainee or group of trainees through individual fines and in certain cases through common fines. Such damage cost will be adjusted in the Caution Deposit paid by the students. When the damage cost exceeds the caution deposit, the excess amount will have to be paid by the students.

7. Academy will take necessary care about any emergencies. Academy's dispensary is equipped with only first aid medical facilities. Academy is not responsible for any personal injury or any disease suffered by any trainees during their training and stay. Any other medical expenses, Doctor consultations should be borne by the candidate's own cost.

8. I understand that I have been admitted as a TRAINEE for the Pre-Sea Training Course which involve training at the campus, workshops, Swimming pool etc., and other ancillary outside training activities such as Boatwork, Firefighting, Ship visits etc., I undertake and agree that neither my executors nor my administrators will make any claim against Academy or against any person in the service of Academy in respect of any injury to the property of person including injury resulting in death which the said TRAINEE may suffer while undergoing this pre - sea training activities thereto I understand and agree that no compensation will be paid by Academy or by any officer or employee of Academy and any person in the service of the academy, against anybody concerned arising out of any act of default on the part of the said TRAINEE or by any officer or employee of the Academy during the training and other physical and social activities that may be organized by the Academy. Academy is not responsible for any kind of Accident/Death/Physical Injuries when they are doing practicals in the Academy or any other place of Training outside the Academy such as swimming pool, Boating etc., Also Academy Instructors, Management is not responsible for any compensation for any incident / Refund of the course fee.
